

I hereby amend the Terms of Reference of the Commission as set out in the Schedule hereto.



TERMS OF REFERENCE

OF THE

JUDICIAL COMMISSION OF INQUIRY INTO CRIMINALITY, POLITICAL INTERFERENCE AND CORRUPTION IN THE CRIMINAL JUSTICE SYSTEM ARISING FROM THE SPECIFIC ALLEGATIONS MADE PUBLIC BY LIEUTENANT GENERAL NHLANHLA MKHWANAZI ON 6 JULY 2025

Amendment of Terms of Reference

1. The Terms of Reference of the Judicial Commission of Inquiry into criminality, political interference and corruption in the Criminal Justice System arising from the specific allegations made public by Lieutenant General Nhlanhla Mkhwanazi on 6 July 2025 published in Proclamation No. 269 of 2025, as amended by Proclamation No. 302 of 2025, is hereby amended by the substitution for paragraph 13 of the following paragraph:

- “13. The Commission shall submit:
- 13.1 an interim report within three months after 17 September 2025;
 - 13.2 a second interim report on or before 29 May 2026; and
 - 13.3 a final report on the completion of the Inquiry, on 31 August 2026.”.
