ON 6 JULY 2025**

Amendment of Terms of Reference

1. The Terms of Reference of the Judicial Commission of Inquiry into criminality, political interference and corruption in the Criminal Justice System arising from the specific allegations made public by Lieutenant General Nhlanhla Mkhwanazi on 6 July 2025 published in Proclamation No. 269 of 2025, is hereby amended by the substitution for paragraph 13 of the following paragraph:

- “13. The Commission shall submit:
 - 13.1 an interim report within three months; and
 - 13.2 a final report within six months,
after 17 September 2025 or such extended period as the President may
determine.”.
