**NOTICE IN TERMS OF RULE 4 OF THE RULES GOVERNING THE
PROCEEDINGS OF THE COMMISSION**

TAKE NOTICE THAT the Evidence Leaders have brought an application before the Commissioners for an order in the following terms, and in respect of the witness scheduled to appear from 1 July 2026:

1. Condoning any non-compliance with the Rules of the Commission regarding the timeframes set for making applications of this nature.
2. Directing, in terms of the Rules of the Commission, that the Applicant's leading of evidence of certain WhatsApp communications of General Khan and related documentary evidence in anticipation of the appearance before the Commission, of General Khan, be held *in camera*;
3. That the legal representatives of General Khan shall be entitled to be present in the *in camera* proceedings.
4. That the legal representatives of General Khan shall be entitled to disclose the contents of the proceedings

- a. to General Khan and,
 - b. solely to the extent necessary, to obtain instructions from a third person, to that third person.
5. That the Chairperson shall specify in the order all other persons who will be permitted to attend the *in camera* proceedings.
6. Directing that the *in camera* proceedings, including any transcript, recording, or documentation, be treated as confidential, and that, subject to paragraph 4 of this order, all persons present during the *in camera* proceedings be prohibited from disclosing any information arising the hearing, subject to the directions of the Chairperson.
7. That such further and/or alternative relief be granted as the Chairperson of the Commission may deem fit.

PLEASE TAKE NOTE THAT the witness will rely on the founding affidavit attached hereto in support of the order sought.

TAKE NOTICE FURTHER THAT, should same be opposed, the media has 72 hours within which to note their opposition to the Commission.
